

Holding Steady in An Unsteady World By Dr. Bruce Barnes

We live in times of unrest, both in our personal lives and globally. It's easy to feel unsettled by the headlines—rising tensions in the Middle East, threats of war, cultural confusion, and political division. These are not light matters. People are troubled, and rightly so. But for the follower of Christ, these trying times call for something more than worry or reaction—they call for faith that stands firm.

The Apostle Paul, writing from prison, urged believers to "take up the whole armor of God." His words in Ephesians 6:13 are not abstract. They are instructions for how to live when darkness presses in. Paul doesn't say to flee. He says to "withstand" and "stand." The battle is not theoretical—it is spiritual, emotional, and sometimes even physical. But God's Word gives the believer a reason to hold steady: we are not standing in our strength.

Faith in God during difficult times is not just a spiritual accessory—it is the very root of inner peace. We may not know what the news will bring tomorrow, but we know the One who rules tomorrow. He is not distant or caught off guard. He has promised to be near to the brokenhearted and to keep in perfect peace those whose minds are stayed on Him (Isaiah 26:3).

"Peace Does Not Come from Perfect Circumstances!"

Peace does not come from perfect circumstances. If that were the case, we would rarely know it. Peace comes when we settle in our hearts that God is in control and that His will cannot be overturned. When we trust His character—His wisdom, power, and goodness—we no longer have to scramble for answers. We can rest. Resilience in trials flows from that kind of settled trust. It's not about pretending the problems don't exist. It's about knowing they don't have the final word.

Many today feel anxiety about world events, especially the volatility in the Middle East. Prophetic passages come to mind. Questions stir. Are these signs of the end? Will war break out? What about Israel, God's chosen nation? These are valid concerns, and Scripture tells us not to be ignorant of the times. But Scripture also tells us not to fear them. Psalm 46:6-7 says, "The nations raged, the kingdoms were moved; He uttered His voice, the earth melted. The Lord of hosts is with us; the God of Jacob is our refuge." God has never lost control of history—not once—and He won't start now.

Faith gives us the ability to look at the storm and say, "I will not be moved." We do not base our hope on world peace but on the Prince of Peace. The armor God provides is meant for battle, not for comfort. Yet, in the wearing of it, we find comfort—because it keeps us close to Christ, who is our shield and strong tower.

What do we do, then, in uncertain times? We keep praying. We continue to read and apply God's Word. We continue to show kindness and share the Gospel. We teach our children to fear the Lord, not the news. We worship in spirit and truth. And when we've done all, we stand.

We may bend in the wind, but we do not break. Why? Because we know whom we have believed, and we are persuaded that He can keep what we have committed to Him until that Day (2 Timothy 1:12).



"Lord, when the world feels unstable, help me to stand firm in Your truth. Strengthen my faith so that I trust You more than I fear the future. Remind me that You are in control, and that You have not called me to panic but to peace. Let my life reflect the quiet confidence of one who knows that You will never fail.

We have a deep and ongoing need for God's wisdom, protection, and favor. Your prayers are vital as we advocate, advise, and stand beside churches on the front lines.

Served with a million-dollar lawsuit. Denied coverage by insurance. No idea where to turn. Until he called us.

Because of partners like you, he didn't face that battle alone. Your support keeps that kind of help available when the next pastor calls.

Lawsuits Are Surging!

Every lawsuit forces churches to divert precious time and resources away from outreach and discipleship-toward legal fights they never expected. And for some, that burden becomes too great.

These cases aren't rare-they're happening every day.

Out of the dozens of urgent calls we receive each day, here are just a few that reveal how serious these threats have become:

A Christian School Pressured to Compromise Its Beliefs

Multiple families attempted to enroll students who openly identified as LGBTQ+. The school, rooted in biblical doctrine, explained its position with clarity and care—but that wasn't enough.

They were accused of discrimination. Threatened with lawsuits. Targeted on social media. Even their accreditation was at risk. *Leadership turned to the NCLL for help.*

We reviewed their admissions policies, fortified their legal protections, and walked with them through every conversation, every threat, and every board meeting. We helped them communicate their convictions with truth and grace—without opening the door to devastating legal consequences.

In the end, the school stood firm-without compromising its mission or legal standing.

A Student Threatens Violence-and the School Has Minutes to Respond

It happened without warning. A student brought a weapon to a Christian school-and made a deadly threat against classmates.

Panic set in. Teachers scrambled to secure classrooms. Law enforcement rushed to the scene. Parents demanded answers.

The school's leadership knew one wrong move-legally or publicly-could jeopardize everything.

They called the NCLL.

We responded immediately-guiding them through mandatory reporting, protecting student privacy, assessing liability, and preparing a clear public response.

Because of swift action and sound legal counsel, the school kept its doors open, its students safe, and its mission intact-proving that even under threat, faith-based education can stand strong.

A Church Confronts a Serious Allegation—and Seeks the Truth with Grace and Integrity

It began quietly-a private allegation that soon became a formal complaint.

A church employee was accused of sexually harassing a fellow congregant. The individual notified church leadership and filed a police report within days.

The accusation sent shockwaves through the congregation. Staff were shaken. Trust was at risk. Leadership faced a legal and moral crisis—with no room for error.

They turned to the NCLL for help.

We knew this required more than legal expertise. It demanded truth, compassion, and precision.

Our team stepped in-advising on immediate legal compliance, protecting the rights of all involved, coordinating with law enforcement, and guiding church leadership through every step.

We helped them respond with wisdom and integrity-avoiding gossip, retaliation, and missteps.

In the end, the church handled the matter lawfully and biblically—protecting their people, preserving their mission, and proving that even in crisis, the Church can be a place of justice and refuge.
